The Bhutan Electricity Authority would like to invite applications from Bhutanese nationals for the following post:

1. Post Title: **Director**
2. Responsibilities : As per the Terms of Reference which can be downloaded from (<http://www.bea.gov.bt/index.php/form/>)
3. Eligibility:
  - 3.1 *Education:* Minimum of Bachelor Degree in Engineering obtained from recognized university through regular (full time) program. However, if the applicant has Master's Degree in relevant field, bonus points will be awarded at the time of the evaluation.
  - 3.2 *Experience:* Minimum of fifteen (15) years of work experience (excluding study leave, EOL, medical leave longer than one month and training period longer than one month) after completion of bachelor's degree in electricity industry, which should include at least five (5) years of active service as Division Chief at P1A level and above for civil servants and General Manager level and above for corporate or equivalent positions.
  - 3.3 *Age limit:* Sixty (60) years of age as of the last date of application submission specified in the announcement.
4. Remuneration per month: Basic pay of Nu 45,000; 40% Contract Allowance; 15% Regulatory Allowance; fuel allowance of Nu 4,000 and mobile telephone allowance of Nu 1,000. No other allowances, including house rent allowance, shall be admissible.
5. Tenure: Five (5) years.
